Supporting and empowering First Nation child and family services agencies in northern Manitoba to enhance and enrich family life

Update: Status of Administration Order

A new process has been established to address the conditions necessary for the Minister of Families to lift the *Order of Administration* and return governance of the Northern Authority to a fully functioning Board of Directors. This process will be led by a political oversight body and will be assisted by a Joint Working Group (JWG) and a Technical Working Group (TWG). Key process activities include identifying criteria and indicators, developing a work plan, implementing the work plan and communicating progress to stakeholders.

In addition, a three-person Advisory Committee has been appointed by MKO to assist in this process. Comprised of representatives of the future board, members of this Advisory Committee are Sydney Garrioch, Michael Yellowback and Daisy Monias.

The Advisory Committee is expected to provide direction and insight in the areas of governance, by-law development, information management activities and support the Northern Authority in delivering on its mandate. The TWG met on February 1st while the JWG met on March 1st. The TWG is scheduled to meet with the Advisory Committee on March 23rd.

Northern Authority Update - News



New Child Maintenance Manual Released!

The updated version of the **Child and Family Services Funding Guideline for Child Maintenance** (dated October 2016) has been released by the province and has been distributed to all agencies.



The Standing Committee has established a new sub-committee called the "Child Maintenance Policy Advisory Committee (CMPAC). CMPAC responsibilities include: identifying/discussing child maintenance issues that have system-wide implications; identifying/developing policy options and making recommendations on policy changes; and communicating policy changes to all authorities, agencies and other stakeholders. Representation on CMPAC includes four agency members (one from each region), four authority members (one from each authority), INAC (one member), and the provincial CFS Division (two members). CMPAC met on February 27th and a draft terms of reference was discussed. Northern representatives are Bev Bee (Awasis) and Darlene Courchene (Northern Authority).
